1. Any person 18 or over as of January 1 of the current year must have paid dues, in their name, prior to showing to be eligible for year end awards.
2. Complete information on any horse must be sent to the AAA Point Secretary by the last day of the first show of the year and be kept current throughout the year.
3. **YOUTH:** Youth exhibitors must follow above rules. "Family" membership is acceptable. AAA must have a copy of the youth's birth certificate. Youth exhibitors must pay dues in their name to the ApHC Youth Club. Ownership of Youth horses follows the guidelines of the current ApHC rule book.
4. **NONPRO:** A NonPro must have paid national dues, have an ApHC NonPro card and be an owner of the horse before they can enter a nationally approved Non Pro class. Ownership of NonPro horses follows the guidelines of the current ApHC rule book.
